## OBJECT: MINUTES RELATING TO THE EXAMINATION OF THE EXPRESSIONS OF INTEREST RECEIVED IN ORDER TO IDENTIFY THE ECONOMIC OPERATORS TO BE INVITED TO THE NEGOTIATED PROCEDURE FOR THE AWARDING OF PR&MR AGENCY, COMMUNICATION, AND PRESS OFFICE SERVICES FOR THE EMILIA ROMAGNA TOURIST DESTINATION FOR AND IN THE GERMAN-SPEAKING MARKETS (DACH: GERMANY, AUSTRIA, SWITZERLAND)

In the year two thousand and twenty-five (2025) on the seventeenth (17th) of the month of January, at 1:00 p.m. in the office of APT Servizi s.r.l., in Rimini, p.le Fellini 3, the RUP (Tender Specialist), Ms Simonetta Monti, examined the expressions of interest following the notice (call for proposals) published on 19/12/2024 on the telematic procurement platform "Acquisti Telematici" and on the company website in the section "Bandi di gara e Richiesta di offerta".

Given that:

with the resolution to contract no. 179 of 10/12/2024, the negotiated procedure for the awarding of PR&MR agency, communication, and press office services for the Emilia-Romagna tourist destination for and in the German-speaking markets (DACH: Germany, Austria, Switzerland) had been started;

with the aforementioned resolution to contract, the tender documents had been approved and the negotiated procedure had been called following an expression of interest, which will take place pursuant to art. 50, paragraph.1, letter e) of Legislative Decree No. 36/2023 (hereinafter the "Code");

It was reiterated that for the selection of economic operators to be invited, a notice (call for proposals) aimed at acquiring specific expressions of interest had been published on 12/19/2024.

It was specified that the electronic management of this tender procedure through the telematic procurement platform "Acquisti Telematici" guarantees compliance with all the security standards required for a public tender procedure (confidentiality, traceability of the times of receipt of the offers, etc.).

The RUP examined the participation requests received on the platform, verifying that they:

1) had been received within the indicated deadline;

2) represented the expression of interest referred to the above object and had been correctly drafted and signed by the legal representative of the Economic Operator (Annex A);

The RUP preliminarily acknowledged that 10 (ten) expressions of interest had been received within the deadline from the following economic operators:

The RUP examined the documentation received in order to ensure that it complied with the indications of the notice of expression of interest (call for proposals).

At the end of the analyses, the RUP noted that all the participation requests were correct, also following additional clarifications obtained in particular from the operator Girasole GmbH regarding the exact indication of the requirement of technical and professional expertise and from the operator Wilde & Partner regarding the option of not resorting to the institute of pooling.



Based on the above findings, considering that all the applications for participation had been received in compliance with the prescribed methods and timeframes and that all the operators had declared that they possessed the required requisites, the RUP has decided to invite them, without exception, to the next phase of the procedure which will be started as soon as possible.

These minutes are published on the Acquisti Telematici platform and on the company website in the section "Bandi di gara e Richiesta di offerta".

At 3:00 pm the RUP declared the examination of the expressions of interest concluded and, after drafting these minutes, closed the session.
